Depending on the province/territory, a power of attorney for property, which remains effective during the grantor's or donor's incapacity, is referred to as continuing or enduring. In Quebec, it is referred to as a protection mandate. In British Columbia a representation agreement covers health and personal care decisions and can also cover routine financial and legal affairs.
