A contingent beneficiary designation enables an annuitant to make a primary and secondary beneficiary designation. The secondary beneficiary designation would only come into effect if the primary beneficiary predeceases the annuitant. A common example of how contingent beneficiary designations are used is for the annuitant to name his or her spouse or partner as the primary beneficiary and to name his or her children as secondary beneficiaries.

Zucchini Brownies

½ cup applesauce

½ cup butter

2 eggs

2 tsp vanilla extract

1 ½ cup sugar

½ cup unsweetened cocoa

1 medium zucchini (cut into small pieces)

2 cups all-purpose flour

1 tsp kosher or sea salt

1 ½ tsp baking soda

1/4 cup chocolate chips

Preheat oven to 350 degrees F

Add applesauce, butter, eggs, vanilla, sugar, cocoa, and zucchini to blender

Add flour, salt and baking soda. "Pulse" 4-6 times or until all flour is incorporated Pour into a greased 9x13" baking pan Bake for 25-30 minutes

Remove from oven and cover with chocolate chips.
