From the Desk of Margaret Gurd Here is a favorite recipe of mine! Crustless Rhubarb Pie!

3 cups chopped rhubarb

1/3 cup flour

3/4 cup sugar

½ tsp baking powder

½ tsp salt

3 extra large eggs (or 4 large eggs)

1 tsp vanilla

1 cup milk

1/4 cup butter melted

Preheat oven to 375*, grease pie plate and spread rhubarb on the bottom. Mix remaining ingredients in a blender and pour over rhubarb. Bake 40-45 minutes (or longer) until cooked and set in the middle. Let sit 15 minutes before cutting. Store in refrigerator.
