How to find out your RRSP and TFSA contribution room

Important information about your contribution room

Please note, if you are checking your contribution room for your Registered Retirement Savings Plan (RRSP) or Tax-Free Savings Account (TFSA) from January to March, the Canada Revenue Agency (CRA) will not be up to date for the previous year's contributions.

Therefore, if you have made contributions or withdrawals in the current or previous calendar year, you may need to adjust for these until your financial institution has reported these details. Always compare the TFSA transaction information we have with your own records to ensure that the information we have on record is correct. The Canada Revenue Agency (CRA) calculates your Registered Retirement Savings Plan (RRSP) deduction limit based on your earned income in previous years. Tax-Free Savings Account (TFSA) contribution room is not based on your income. Every year, you may contribute up to the TFSA dollar limit plus any TFSA withdrawals or unused contribution room from previous years.

Here's how to check your contribution room:

On the CRA website

1. Visit the CRA website, "<u>My</u><u>Account for Individuals</u>" page.

2. Click to Log in through a sign-in partner with your bank information or with your CRA ID and Password.

3. After you log in, you can scroll the main page until you see your RRSP and TFSA Contribution Room.
