For foreign investment income that is subject to non-resident withholding tax (e.g. U.S. dividends), we have assumed a non-resident withholding tax rate of 15%. If the foreign withholding tax rate is anything other than 15%, the results will be different. We have provided this integrated rate for illustration purposes only.
